In the event of an **incident or emergency situation**, where Safe Guide / GGC Code of Conduct determines a need to notify and/or involve Provincial/National in the management of the situation, all Guiders should contact the Provincial reps in the following order, until one is reached.

Examples of when you should make contact are:

- Emergencies during Guiding events: such as: car accidents, missing members, intruders, evacuations, etc.
- Outside Medical attention required (paramedic / Clinic / hospital, ambulance, etc) or escalated behavioral issues with parents or Guiders.
