The value of this scholarship is \$1000.00

OBJECTIVES

- To further promote the Vision, Mission and Values of Girl Guides of Canada.
- To encourage education for members of Girl Guides of Canada enrolled in a professional post graduate school in Canada.

ELIGIBILITY

To be eligible for this bursary the applicant must:

- Be an active member in good standing of Girl Guides of Canada.
- Have been an active member in BC Guiding for the last five years.
- Be entering or continuing in a professional post graduate school in Canada.

GUIDELINES

- This scholarship will be awarded to an applicant who is entering or continuing in a
 professional post graduate school. If no suitable application is received, the scholarship
 will not be presented for that year.
- Current application forms are available from Girl Guides of Canada, BC Council
 <u>Scholarships page</u>, under the awards section. To be considered, current application
 forms must be filled out **completely** with no additional information and **must be submitted by the deadline**. Application forms and reference forms must be **signed and** dated. The use of incorrect or out of date forms will result in disqualification of the
 application.
- In some sections of the application form a maximum number of words are designated for the response. Additional information will not be considered after the maximum number of words has been reached.
- A member can only win this scholarship once. Applicants who are not successful can reapply.
- This scholarship is conditional upon acceptance at the institution of the recipient's choice and will be awarded only when proof of registration (in the form of a receipt for tuition paid), the recipient's Social Insurance Number and a recent headshot photograph of yourself in Guiding uniform, that is in colour and is high-resolution, have been received by the provincial awards committee.
- This scholarship must be used within 12 months of the date of notification.
- Successful applicants may receive only one adult bursary, grant or scholarship per year.
- Successful scholarship recipients must agree to be profiled in GGC materials such as news releases, Canadian Guider and Pipeline articles, and on www.girlguides.ca or www.bc-girlguides.org in order to help promote Guiding and our bursary, grants and scholarship program.
