

PAT DRUGGE ADULT BURSARY CRITERIA



ONLY THE CURRENT APPLICATION FORM (January 2020) WILL BE ACCEPTED

The bursary was established by BC Guiding Members to recognize the many contributions to Guiding by Pat Drugge. Initial contributions to the fund were in the form of a retirement gift to Pat, from her Guiding friends, as she completed her term as Provincial Commissioner.

OBJECTIVE

To assist Guiders who have a need for financial assistance to further and/or upgrade their education or job skills.

FINANCIAL INFORMATION

- Donations may be made to the Pat Drugge Adult Bursary Fund.
- Individuals donating will receive a charitable tax receipt (if the donation is less than \$10 the receipt must be requested).
- 5.5% of the Pat Drugge Adult Bursary Fund, as of January 1 of the current year, will be available for distribution. The number and value of bursaries, awarded each year, are at the discretion of the provincial awards committee.

ELIGIBILITY

To be eligible for this bursary the applicant must:

- Be 25 years or older
- Be an active adult member in good standing of Girl Guides of Canada—Guides du Canada
- Have been active in BC Guiding for the last three years

GUIDELINES

- Bursaries will be considered for all types of education, including high school equivalency, technical or career programs and college or university courses.
- The Pat Drugge Adult Bursary may be applied to tuition or other expenses such as childcare, books, supplies and transportation.
- Current application forms are available from the BC Girl Guide <u>Scholarships page</u>, under the Awards Section. To be considered, current application forms must be filled out completely, with no additional information, and must be submitted by the deadline. Application forms and reference forms must be signed and dated. The use of incorrect or out of date forms will result in disqualification of the application.
- In some sections a maximum number of words are specified for the response.
 Additional words will not be considered.
- This bursary is conditional upon acceptance at the institution of the recipient's choice.
- This bursary will be awarded only when proof of registration (in the form of a receipt for tuition paid), the recipient's Social Insurance Number and a recent headshot photograph of yourself in Guiding uniform, that is in colour and is high-resolution, have been received by the provincial awards committee.
- The bursary must be used within 18 months of the date of notification.
- Successful bursary recipients must agree to be profiled in GGC materials such as news releases, *Canadian Guider* and *Pipeline* articles, and online at www.girlguides.ca or

<u>www.bc-girlguides.org</u>, in order to help promote Guiding and the bursary, grant and scholarship program.

- The recipient(s) is to continue her involvement in Guiding in whatever way possible.
- All applicant(s) will be notified of the results.
- Formal announcement of the recipient(s) will be made at the BC Council Annual General Meeting and published in *Pipeline*.
- Unsuccessful applicants may reapply.
- Successful applicant(s) may reapply once only.
- An applicant is eligible to receive only one bursary, grant or scholarship in the same year.

APPLICANTS WILL BE EVALUATED IN TERMS OF THE FOLLOWING:

- Involvement in Guiding
- · Experiences outside of Guiding
- Employment
- Future education/training
- Financial need
- Statement on Guiding

LATE APPLICATIONS WILL NOT BE CONSIDERED
