

Raising our voices: the world we want for girls and young women

The World Association of Girl Guides and Girl Scouts (WAGGGS) have selected Krysta Coyle, a Girl Guide leader with Girl Guides of Canada in Halifax, as a member of its youth delegation to the 60th session of the United Nations Commission on the Status of Women (CSW60) in New York. CSW is an annual event, being held in 2016 from 14-24 March, to evaluate progress on gender equality, set global standards, and formulate concrete policies. The delegation will add their voice to those demanding a better future for girls and young women.

Last September, world leaders gathered at the United Nations (UN) in New York and agreed on a set of global Sustainable Development Goals (SDGs) to eradicate extreme poverty by 2030, fight inequality and injustice, and tackle climate change. The SDGs explicitly recognise that gender equality is critical to the progress of all goals. The priority theme for CSW60 is women's empowerment and its link to sustainable development.

Attending the 60th session will provide an opportunity for the WAGGGS delegation to ensure that the voices of 10 million Girl Guides & Scouts in 146 WAGGGS member countries around the world are heard on the issues that matter to them.

"Attending CSW60 is an opportunity to influence decision-makers so that the aspirations contained in the SDGs are implemented and translated into real progress in the lives of girls and young women" Krysta says. "All over the world, girls and young women continue to face unique challenges because of the double discrimination of their sex and age, so there is work to be done in every country in the world to achieve full gender equality. The new goals are universal, therefore all governments have a strong imperative to turn their promises into tangible action on the ground for girls, and we will be ensuring this takes place"

Key issues the WAGGGS delegates will be advocating for governments to commit to at CSW60 include:

- Combating discriminatory social norms and practices, especially violence against women and girls
- Building the capacity of girls and young women to participate in and drive change for a better world
- Investing in specialised programmes aimed at girls and young women
- Developing systems that assess the impact of the goals on girls and women for truly reflective societal progress
